This Privacy Notice sets out the obligations of Quick Car Credit Ltd, (QCC) a company registered in the UK under 09025185, whose registered office is at 168 Crewe Road Haslington Crewe CW1 5RN regarding data protection and the rights of individuals in respect of their personal data under the General Data Protection Regulation (“GDPR”).

What we do

QCC sell cars and help individuals to apply for the finance to purchase one of our stock vehicles. Any personal information we collect to do this will be processed in accordance with the GDPR.

Our Lawful Basis for Processing

In most cases the Lawful Basis for Processing as defined in the GDPR will be under a contract with us for us to provide this service. We will need personal information from you to apply for the finance you require to allow the purchase of a vehicle from us. However, before we send you any electronic marketing we will first obtain your explicit consent.

Sharing your personal data

We will need to share your personal data with one or more finance companies, so they can assess your credit worthiness and process your application for finance. When we process your application, we will pass your personal data to the finance company most suitable to your individual circumstances. Personal data received from other sources

If we receive any personal data from any other source or organisation, we will inform you within 1 month from receiving the data and provide you with our Privacy Notice.

Retention of your personal data

Security

We will ensure that your personal data will be stored with appropriate security whether on our IT system or in paper form.

Any personal data we hold that is stored outside of our IT system, meaning that it is stored within a cloud, is located within the EEA and therefore complies with the GDPR.

Individual Rights

The GDPR gives individuals certain rights. These are as follows:

- The right to be informed about our use of your personal data
- The right of access to the personal data we hold about you
- The right to rectification if any personal data we hold is inaccurate
- The right to erasure (also known as the 'right to be forgotten') where there is no overriding legitimate interest for us to continue holding your personal data
- The right to restrict processing
- The right to data portability (Obtaining a copy of your personal information to re-use with another organisation)
- The right to object
- Rights with respect to automated decision making and profiling
- The right to withdraw your consent for marketing purposes
